- Military banner will be displayed in Wentzville. Banners are also available for purchase through Heros program in honor of fallen service perople.

- Alderman Hussy addressed potholes. If you have issues with potholes, report to city via website or you can send an email to the city.
- Golf Course thanked residents for monitoring golf course and reporting concerns. Improvements cleaned up bushes on 13th hole and working on stone wall. T-boxes have been sodded, trees planted/removed. Clubhouse is being utilized a lot for weddings. This year the golf course is getting new golf carts with GPS. These can be tracked at the golf course. A few more t-boxes are being put in and hail damage repairs are ongoing.

- No fishing in lakes. Personal golf carts are not allowed on golf course.

- Newsletter will reflect repairs and what improvements have been made to the subdivision.
- Homeowner concern on lifeguards and the associated cost. Recommended to have pool pass holders waive liability and remove lifeguards.
- Homeowner was interested in raising assessment by \$50 specifically for pool reserve.
- Trustees to meet together to decide if assessments should be raised by \$50/year for capital improvement fund.
- First 2 weekends in May to be looked at for pool pass pickup at pool parking lot. Pool forms are available online.
